#### III SOURCE OF TITLE:

<u>In respect of Sy no.11/1 measuring 5 acres 31 guntas and Sy no.11/2 measuring 1 acre 14 guntas :</u>

On perusal of documents produced for scrutiny, it is noticed that land bearing Sy no.11 measuring 8 acres 37 guntas situated at Mallasandra Village, Uttarahalli Hobli, Bangalore South Taluk was earlier owned by one Sri.Anjanappa S/o Sri.Hanumaiah, he having acquired the same from one Sri.Moodlappa S/o Sri.Thimmaiah in terms of a Sale Deed dated 01.08.1932 (doc no.421/1932-33).

Subsequently, the said Sri.Anjinappa S/o Sri.Hanumaiah sold and conveyed land bearing Sy no.11 measuring 2 acres situated at Mallasandra Village, Uttarahalli Hobli, Bangalore South Taluk in favour of Sri.Kadarappa, S/o Sri.Vasanthappa by virtue of a Sale Deed dated 10.10.1938 (doc no.1249).

The land acquired by Sri.Kadarappa was assigned Re-Sy no.11/2 measuring 3 acres 22 guntas including 02 guntas kharab land as recorded in the given revenue records, including RTCs issued by the office of Tahsildar/Village Accountant, Bangalore South Taluk. However, copy of order passed by ADLR with regard to increase in measurement in respect of Sy no.11/2 is not made available.

After the demise of Sri.Anjanappa, his children viz., Sri.Doddahanumaiah and Sri.Karihanumaiah entered into a Partition Deed dated 10.04.1974 (doc no.344/1974-75) for division of land bearing Sy no.11/1 measuring 6 acres 37 guntas of Mallasandra Village among other properties. In terms of the said partition, land measuring 4 acres 17 guntas in Sy no.11/1 was allotted to the share of Sri.Doddahanumaiah and land measuring 2 acres 20 guntas in Sy no.11/1 was allotted to the share of Sri.Karihanumaiah.

After the demise of Sri.Kadarappa, the katha in respect of land measuring 3 acres 20 guntas in Sy no.11/2 of Mallasandra Village was transferred to the names of Smt.Muniyamma W/o Late Sri.Chinnappa (brother of Kadarappa) and Sri.Narasimhaiah, Sri.Obalappa, Sri.Muniraju and Sri.Lakshmaiah [children of Late Sri.Thippanna (brother of Sri.Kadarappa)] in terms of IHC no.3/83-84 issued by the Deputy Tahsildar, Bangalore South Taluk. It is recited in the said IHC that Sri.Kadarappa (kathedar) and his wife both died issueless AND his brother Sri.Chinnappa also died issueless leaving behind his wife Smt.Muniyamma.

Subsequently, Sri.Narasimhaiah, Sri.Muniraju, Sri.Obalappa, Sri.Muniraju and Sri.Lakshmaiah sold and conveyed the land measuring 1 acre 20 guntas in Sy no.11/2 situated at Mallasandra Village, Uttarahalli Hobli, Bangalore South Taluk in favour of Sri.N.Raju in terms of a Deed of Absolute Sale dated 21.04.1994 (doc no.632/1994-95). The said sale transaction is reflected in the mutation register bearing MR no.5/1994-95 issued by the Deputy Tahsildar, Bangalore South Taluk, Bangalore.

The aforesaid Sri.Karihanumaiah alias Kariyappa for self and as father and natural guardian for his minor son Ramakrishna, Sri.Anjanappa and Sri.Chandrashekar sold and conveyed land measuring 1 acre 14 guntas in Sy no.11/1 situated at Mallasandra Village, Uttarahalli Hobli, Bangalore South Taluk in favour of Smt.Chengamma under a Deed of Absolute Sale dated 31.08.1994 (doc no.5398/1994-95). The factum of sale stands corroborated in the mutation register bearing MR no.9/1994-95 issued by the Village Accountant, Bangalore South Taluk.

Similarly, Sri.Doddahanumaiah, Sri.D.Keshavamurthy, Sri.D.Shekar and Sri.D.Puttaraju sold and conveyed land measuring 4 acres 17 guntas in Sy no.11/1 measuring 4 acres 17 guntas situated at Mallasandra Village, Uttarahalli Hobli, Bangalore South Taluk in favour of Smt.Chengamma by virtue of an Absolute Sale Deed dated 31.08.1994 (doc no.5399/1994-95). The sale transaction is entered in the mutation register bearing MR no.7/1994-95 issued by the Village Accountant, Bangalore South Taluk.

Subsequently, Sri.N.Raju sold and conveyed land bearing Sy no.11/2 measuring 1 acre 20 guntas situated at Mallasandra Village, Uttarahalli Hobli, Bangalore South Taluk in favour of Smt.Chengamma in terms of a Deed of Absolute Sale dated 04.05.1995 (doc no.1316/1995-96). The factum of sale transaction is reflected in the mutation register bearing MR no.26/1995-96 issued by the Deputy Tahsildar, Bangalore South Taluk, Bangalore.

The said Smt.Chengamma executed a Will dated 09.08.1996 (doc no.254/1997-98) bequeathing land measuring 14 acres 33 guntas in Sy nos.11/1, 11/2, 10 & 9/1 situated at Mallasandra Village, Uttarahalli Hobli, Bangalore South Taluk in favour of her son Sri.K.M.Srinivasa Murthy.

The land bearing Sy no.9/1 measuring 2 acres 34 guntas, 10 measuring 4 acres 28 guntas, 11/1 measuring 5 acres 31 guntas and 11/2 measuring 1 acre 20 guntas of Mallasandra Village were converted from agriculture to non-agricultural residential purpose vide official memorandum dated 31.03.1998 bearing no.BDIS.ALN.SR(S)279/1997-98 issued by the office of Deputy Commissioner, Bangalore District, Bangalore. The Land Owner Sri.K.M.Srinivasa Murthy has executed a Declaratory Affidavit dated 12.02.2016 (notarised) confirming that upon enquiries made, he was informed that Smt.Muniyamma, one of the predecessors-in-title died intestate before the execution and registration of sale deed dated 21.04.1994 (doc no.632/1994-95).
