

Sub: Issue of Corrigendum to the consent for operation (CFO) with respect to M/s. Aratt One World Pvt. Ltd., located at Sy No.82/1, 83/1, 84/2, 84/3, 84/4, 84/5, 85/1 and 86/2, veerasandra village, Attibele hobli, Anekal Taluk, Bengaluru Urban District- reg

This office had issued the Consent for establishment (CFE) to M/s. Aratt One World Pvt. Ltd., located at Sy No.82/1, 83/1, 84/2, 84/3, 84/4, 84/5, 85/1 and 86/2, Veerasandra village, Attibele Hobli, Anekal Taluk, Bengaluru Urban District for the construction of residential apartment with 166 flats having a total built up area of 35291.60Sqmts vide ref (1) cited above.

Now, the applicant has submitted a letter to Regional office RO Sarjapura stating that in the Consent for establishment was issued for the Sy No.82/1, 83/1, 84/2, 84/3, 84/4, 84/5, 85/1, Veerasandra village, Attibele Hobli, Anekal Taluk, Bengaluru Urban District but Sy No.86/2 was not reflected in the CFE order. In this regard the applicant has submitted the site proposed plan and EC obtained from SEIAA and stated that while uploading the application in online the Sy No. 86/2 was by oversight not mentioned, hence requested to issue corrigendum to the consent for establishment issued.

Further, the request made by the applicant and as per the letter of Regional officer RO Sarjapura, was verified and found correct and hence, the following addendum order issued.
