

2. It was a common practice of the revenue department to assign sub-division numbers wherever large extents in a single survey number had multiple owners for sake of convenience of maintenance of the preliminary records. The sub-division numbers assigned in the preliminary records appear to be continued in the RTC/Pahani despite the lands not being sub-divided by the survey department. Krishnama Raju son of late Narasaraju by a Deed of Sale dated 11.08.1960 (Document No.3) sold 3 Acres in Portion of Survey No. 87/3 to Channa Krishnaiah Shetty son of Channa Nanjundaiah, who in turn re-conveyed the same Krishnama Raju son of late Narasaraju under a Deed of Sale dated 26.02.1962 (Document No.4).
14. Narasaraju, his wife Chennamma and their children Krishna Raju, Ashwath and Doraiswamy by a Deed of Sale dated 14.12.1983 (Document No.15) sold the 2 Acres in Portion Survey No. 87/3 to Susheela N. Reddy wife of late C. Narayana Reddy. On an application being made for transfer of khata, Susheela N. Reddy wife of late C. Narayana Reddy was registered as khatedar of 02 Acres in Survey No. 87/3 in the revenue records, by way of Mutation Register Extract bearing MR No.53/1987-88 (Document No.16).
15. Susheela N. Reddy wife of late C. Narayana Reddy made an application to the Special Deputy Commissioner, Bangalore District, Bangalore for the conversion of 2 Acres in Portion of Survey No. 87/3 from agricultural to non-agricultural purpose. The Special Deputy Commissioner, Bangalore District, Bangalore, upon the receipt of the requisite conversion fines, by way of an Official Memorandum bearing No. B. Dis: ALN: SR: (S): 139/2005-06 dated 25.10.2005 (Document No.30), sanctioned the conversion of 02 Acres in Portion of Survey No. 87/3 from agricultural to non-agricultural residential purpose ("Portion-A"). The said conversion has been recorded in the revenue records of Survey No. 87/3, by way of Mutation Register Extract bearing MR No.17/2005-06 (Document No.31).
16. Upon the death of Krishnama Raju his sons K. Narasaraju and K. Vasuraju by a Deed of Sale dated 26.06.1974 (Document No.5) sold 3 Acres in Portion of Survey No. 87/3 to Lakshman son of Chandrappa. On an application being made for transfer of khata, Lakshman son of Chandrappa was registered as khatedar of 3 Acres in Survey No. 87/3 in the revenue records, by way of Mutation Register Extract bearing MR. No. 9/1974-75 (Document No.6).
17. Lakshman son of Chandrappa by a Deed of Sale dated 12.06.1986 (Document No.17) sold 3 Acres in Portion of Survey No. 87/3 to C. Muni Reddy son of Channappa. On an application being made for transfer of khata, C. Muni Reddy son of Channappa was registered as khatedar of 3 Acres in Survey No. 87/3 in the revenue records, by way of Mutation Register Extract bearing MR No. 52/1987-88 (Document No.18).
18. C. Muni Reddy son of Channappa by a Deed of Gift dated 17.10.2003 (Document No.23) gifted 3 Acres in Portion of Survey No. 87/3 to his nephew, N. Shashank Kumar son of late C. Narayana Reddy. On an application being made for transfer of khata, N. Shashank Kumar son of late C. Narayana Reddy was registered as khatedar of 3 Acres in Survey No.

87/3 in the revenue records, by way of Mutation Register Extract bearing MR No. 21/2003-04 (Document No.24).

19. N. Shashank Kumar son of late C. Narayana Reddy, made an application to the Special Deputy Commissioner, Bangalore District, Bangalore for the conversion of the 3 Acres in Portion of Survey No. 87/3 from agricultural to non-agricultural purpose and the Special Deputy Commissioner, Bangalore District, Bangalore upon receipt of the requisite conversion fines, by way of an Official Memorandum bearing No. B. Dis: ALN: SR: (S): 136/2005-06 dated 25.10.2005 (Document No.32), sanctioned the conversion of 3 Acres in Portion of Survey No. 87/3 from agricultural to non-agricultural residential purpose ("Portion-B"). The said fact of conversion has been recorded in the revenue records of Survey No. 87/3, by way of Mutation Register Extract bearing MR No. 18/2005-06 (Document No.33).

20. The land in Survey No. 87 measuring 57 Acres 11 Guntas i.e., the Larger Property and other properties in Kothanur Village were notified for acquisition for the formation of Layout called "Jayaprakash Narayana Nagar VIII Stage" by the Bangalore Development Authority, under a Preliminary Notification dated 23.03.1988 bearing No. BDA: SLAO: AC: PR: 229/1987-88 published in the Karnataka Gazette on 26.05.1988 (Document No.61) and whereas subsequently, by a Final Notification dated 19.10.1994 bearing No. HUD: 292: MNX: 1993 published in the Karnataka Gazette on 19.10.1994 (Document No.62), the State Government acquired the Larger Property.

21. Susheela N.Reddy and C.Muni Reddy (Susheela & Another") filed a Writ Petitions bearing W.P No. 32881/1994 c/w 3324 and 3325/1995 and other writ petitions before the High Court of Karnataka, seeking to quash the Notifications dated 23.03.1988 and 19.10.1994 in so far as Portion of Survey No.87/2, Portion-A and Portion-B were concerned. The Hon'ble court, by its Order dated 26.09.1996 (Document No.63) (i) allowed all the writ petitions, (ii) quashed the Final Notification dated 19.10.1994, as prior sanction of the scheme by the Government under Section 18 (3) of Bangalore Development Authority Act 1976 was not obtained and (iii) reserved the liberty to government to pass appropriate order after considering the objections filed by the Susheela & Another and to complete the process within one year from this Order.

22. Aggrieved by the aforesaid Order dated 26.09.1996 passed in W.P. No. 3324 & 3325/1995 Susheela & Another preferred a Writ Appeal bearing W.A. No. 1002-10023/1996, before the High Court of Karnataka, the Hon'ble Court by its Order dated 03.07.1998 (Document No.65) dismissed the said appeal.

23. Pursuant to the Order passed in W.P No. 32881/1994 c/w 3324 and 3325/1995 dated 26.09.1996 (Document No.63) on obtaining Government approval under Section 18(3) of Bangalore Development Authority Act 1976, the State Government by a Final Notification bearing No. UDD: 434: MNX: 97 dated 17.09.1997, published in Karnataka State Gazette on 18.09.1997 (Document No.64) acquired the portion of Survey No. 87 measuring about 7 Acres 30 Guntas i.e., Converted Portion of Survey No. 87/2.

24. Subsequently, the Government of Karnataka by a Notification bearing No. UDD: 591: MNX: 97 dated 22.09.1999, published in the Karnataka Gazette on 23.09.1999 and issued under Section 48(1) of the Land Acquisition Act, 1894, (Document No.66), withdrew from acquisition, a portion of the Larger Property measuring 18 Acres 30 Guntas (inclusive of 7 Acres 30 Guntas acquired vide Final Notification dated 17.09.1997), which had been notified for acquisition for the formation of Layout called "Jayaprakash Narayana Nagar VIII Stage" under Preliminary Notifications dated 26.05.1988, 02.06.1988, 09.06.1988 as well as under the Final Notification dated 19.10.1992, 19.10.1994 and 17.09.1997.

25. Thereafter however, the State Government, by a Notification bearing No. UDD: 591: BLAQ: 97 dated 19.08.2000 (Document No.68) withdrew the aforesaid Notification dated 23.09.1999 under which acquisition proceedings of 18 Acre 30 Guntas was dropped and by a Final Notification dated 07.10.1999 bearing No. UDD: 485: MNX: 99 (Document No.67), acquired 28 Acres 30 Guntas in the Larger Property which was described as government reserved kaval.

26. Aggrieved by the aforesaid Notification bearing No. UDD: 591: BLAQ: 97 dated 19.08.2000 (Document No.), Susheela N. Reddy her sons N. Swaroop Kumar & N. Shashank Kumar wife and sons of late C. Narayana Reddy & C. Muni Reddy son of late Channappa filed a Writ Petition bearing No. 32095 32098/2009 c/w 31892/2009 c/w. W.P. Nos. 377-378/2002 and R.F.A. No. 259/2010 on file of the High Court of Karnataka against the State of Karnataka, Bangalore Development Authority & Special Land Acquisition Officer, seeking to quash the said Notification dated 19.08.2000. The Hon'ble Court by its Order dated 09.10.2012 (Document No.69) allowing the said petition, quashed the Notification dated 19.08.2000 and Final Notification dated 07.10.1999, on the ground that the acquisition proceedings were defective due to owners of the land not being notified at any point of time.

27. N. Swaroop Kumar son of late C. Narayana Reddy, Susheela N. Reddy wife of late C. Narayana Reddy, N. Shashank Kumar son of late C. Narayana Reddy, C. Muni Reddy son of Chennappa ("Swaroop Kumar & Others") and M/s. Sobha Developers Private Limited ("SDPL"), entered into a Memorandum of Understanding dated 02.01.2004 ("MOU") (Document No.25) read with Agreement of Sale dated 10.02.2004 & Supplemental Agreement dated 21.08.2004 (Document Nos.26 & 27) under which SDPL agreed to purchase 12 Acres 30 Guntas which is inclusive of Converted Portion of Survey No. 87/2, Portion-A and 1 Acre in Portion-B subject to Swaroop Kumar & Others obtaining Notification withdrawing the said lands from acquisition proceedings by the Bangalore Development Authority.

28. Swaroop Kumar & Others sought to cancel the MOU and Agreement of Sale dated 10.02.2004 and aggrieved by the same SDPL filed Arbitration Application bearing A.A. No. 480/2008 on file of the VI Additional City Civil Judge, Bangalore against Swaroop Kumar & Others seeking for temporary injunction restraining the Swaroop Kumar & Others from alienating Portion of Survey No. 87/2, Portion-A & 1 Acre in Portion-B and other lands in all measuring about 12 Acres 30 Guntas, which was allowed till the adjudication of the matter by the Arbitral Tribunal, by its Order dated 09.04.2009 (Document No.34).

29. Aggrieved by the aforesaid Order dated 09.04.2009 passed in A.A. No. 480/2008, Swaroop Kumar & Others filed Miscellaneous First Appeal bearing M.F.A No. 6739/2009 on file of the High Court of Karnataka against M/s. Sobha Developers Limited, wherein the said appeal was rejected by its Order dated 22.07.2010 (Document No.36).

30. M/s. Sobha Developers Limited filed a Civil Miscellaneous Petition bearing C.M.P. No. 22/2009, on the file of High Court of Karnataka, Bangalore, against Swaroop Kumar & Others seeking to appoint an arbitrator for resolving the dispute between the parties. The Hon'ble High Court by its Order dated 03.02.2010 (Document No.35) allowed the said Petition and appointed R. Gururajan, Former Judge, High Court of Karnataka as Sole Arbitrator.

31. M/s. Sobha Developers Limited and Swaroop Kumar & Others thereafter filed a Compromise Petition in Arbitration Dispute bearing CMP No. 22/2009 on 20.09.2010 (Document No.37) before Hon'ble Justice R. Gururajan, the Sole Arbitrator, wherein Swaroop Kumar & Others agreed inter alia to execute the Sale Deed in favour of M/s. Sobha Developers Limited upon Sobha Developers Limited obtaining the notification for withdrawal of acquisition proceedings of Portion of Survey No. 87/2, Portion-A, 1 Acre in Portion-B and other lands measuring in all about 12 Acres 30 Guntas and also sought for an award to be passed in terms of the said compromise. The Hon'ble Mr. Justice R. Gururajan, Sole Arbitrator, taking the Compromise Petition on records, passed an Award dated 20.09.2010 (Document No.38) in terms of the compromise. .

32. A Public Notice was issued M/s. Sobha Developers Limited in the Hindu (English Edition) and Prajavani (Kannada Edition) being local daily newspapers on 23.04.2015 (Document No.39), seeking for objections if any, from the general public to the purchase of the Portion of Survey No. 87/2, Portion-A, 1 Acre in Portion-B and other lands. We have not received any objections till date in response to the Public Notice so issued.

33. (a) N.Swaroop Kumar son of late C. Narayana Reddy (for self and as father and natural guardian of his minor sons Narayan Swaroop and Navarathan Swaroop), (b) Susheela N.Reddy wife of late C. Narayana Reddy and (c) Shashank Kumar N. son of late C. Narayana Reddy by a Deed of Sale dated 04.06.2015 (Document No.41) sold the Converted Portion of Survey No. 87/2, Portion-A, 1 Acre in Portion-B to Sobha Limited (formerly Sobha Developers Limited).

34. Sobha Limited availed a loan facility from the Aditya Birla Finance Limited which was secured by depositing the original documents of title pertaining to Portion of Survey No. 87/2, Portion-A, 1 Acre in Portion-B, by a Memorandum of Deposit of Title Deeds dated 04.12.2015 (Document No.42) and the said mortgage was subsequently discharged by way of Discharge Deed dated 14.09.2017 (Document No.53).

35. Sobha Limited availed another loan facility from RBL Bank Limited which was secured by depositing the original documents of title pertaining to Converted Portion of Survey No.87/2 by a Memorandum of Deposit of Title Deed dated 21.04.2018 (Document No.54). The said mortgage subsists.

36. The Tahsildar, Bangalore South Taluk initiated proceedings in case bearing No. LND: RA (S): 18/2016-17, on the file of the Assistant Commissioner, Bangalore South Sub-Division, Bangalore, under Section 136 (2) of The Karnataka Land Revenue Act, 1964, against Susheela N.Reddy, N.Shashank Kumar, C.Munireddy and others, seeking to register the State Government as khatedar, on the grounds of Survey No. 87 being Sarkari Kharab. The Assistant Commissioner vide its Order dated 26.05.2017 (Document No.50) instructed the Tahsildar to cancel all khatas and register the State Government as khatedar of the Larger Property, save and except 5 Acres in the revenue records. Accordingly, by way of Mutation Register Extract bearing MR. No. H13/2016-17 (Document No.51), the Tahsildar registered State Government as khatedar of Portion-A and Portion-B having cancelled the khatas of Susheela N.Reddy and N.Shahank Kumar.

37. Aggrieved by the said aforesaid Order dated 26.05.2017 (Document No.50) Sobha Limited filed a Writ bearing WP. No. 25896/2017 on the file of High Court of Karnataka, Bangalore against the State of Karnataka, the Assistant Commissioner, and Tahsildar, Bangalore South Taluk. The Hon'ble High court by an Order dated 20.06.2017 (Document No.52), granted an interim stay on the impugned Order dated 26.05.2017 in Appeal No. LND: RA(S): 18/2016-17 of the Assistant Commissioner, Bangalore South Taluk and thereafter by a common Order dated 07.02.2022 in WP. No. 25877/2017 c/w 25896/2017 & other writ petitions (Document No.55), the Hon'ble High court interalia quashed the impugned Order dated 26.05.2017 and directed that the revenue entries shall be restored as they were prior to the impugned orders were passed. Accordingly, the name of the Government was removed and Lakshamma wife of late Krishna Raju, her sons Srinivasa Murthy, Balaji and Krishnamma wife of late Krishnamaraju, were registered as khatedars of their respective portions in Survey No. 87 measuring about 12 Acres 20 Guntas (earlier part of Survey No. 87/3) by way of Mutation Register Extract bearing MR. No. T12/2022-23 (Document No.56).

38. On an application being made by Sobha Limited to the Bruhat Bangalore Mahanagara Palike ("BBMP"), the Converted Portion of Survey No. 87/2 i.e., 7 Acres 30 Guntas and 2 Acres in Survey No. 87/3 were assessed to tax and assigned Municipal No.2326/Sy No.87/2/Sy No.87/3, Kothanur Village, Ward 194-Gottigere, Bangalore vide Special Notice bearing No. Vale: PR: KTR: 135/2015-16: MR: 18/15-16, dated 31.12.2015 (Document No.45) read with Receipts both dated 21.12.2015 (Document Nos.43 & 44) acknowledging the payment of improvement charges & khata fees and Sobha Limited has been registered as khatedar of Municipal No.2326/Sy No.87/2/Sy No.87/3, Kothanur Village, Ward 194-Gottigere measuring in all about 9 Acres 30 Guntas, as may be gathered from the Khata Certificate and the Khata Extract both dated 01.01.2016 (Document Nos.46 & 47). Sobha Limited has paid the tax for the years 2008-09 to 2017-18 with regard to Municipal No.2326/Sy No.87/2/Sy No.87/3, Kothanur Village, Ward 194-Gottigere as evident from the

Property Tax Paid Receipts dated 01.01.2016, 04.01.2016, 30.06.2016 and 24.05.2017 (Document Nos.48 & 49). The present owners are recommended to obtain E-Khata in their name with regard to the aforesaid property.

39. Some parts of Converted Portion of Survey No. 87/2, Portion-A and 1 Acre in Portion-B belonging to Sobha Limited were notified for acquisition under Preliminary Notification dated 21/22.09.2015 published in the Karnataka Gazette on 08.10.2015 (Document No.70), and thereafter a part of the notified area was acquired for the purpose of developing the second phase of Bangalore Metro Rail Project by the Ministry of Commerce and Industry under Final Notification dated 22.02.2018 (Document No.71) and remaining excluded under Notification dated 22.02.2018 (Document No.72) both published in the Karnataka Gazette on 01.03.2018, as detailed in the table below:

40. The Sketch issued by Bangalore Metro Rail Corporation Limited, approved by the BMRCL (Document No.73) shows the location of aforesaid portions acquired under ID. Nos. DP-1/B, DP-1/D and DP-1/E for Section: R6 Elevated: Gottigere to Swagath Road Cross, Kothnur Depot.

41. We are given to understand that though Sobha Limited are the owners of 5 Acres 35 Guntas in the Larger Property, the actual physically available area is being only 5 Acres 34 Guntas, Sobha Limited have applied for sanction of development plan with regard to 5 Acres 34 Guntas in the Larger Property i.e. all that piece and parcel of Property being portion of Municipal No.2326/Sy No.87/2/Sy No.87/3, Kothanur Village, Ward 194-Gottigere measuring in all about 5 Acres 34 Guntas i.e., 23668.68 square metres (i.e., portions of residentially converted land bearing Survey No.87/2 and Survey No.87/3 both situated Kothanur Village, Uttarahalli Hobli, Bangalore South Taluk situated Kothanur Village, Uttarahalli Hobli, Bangalore South Taluk) hereinafter referred to as "Project Lands".

42. On an application being made by Sobha Limited seeking for the approval of development plan for construction of residential apartment building on Project Lands, the Development Plan was approved by the Bangalore Development Authority by way of Work Order bearing No. BDA/TPM/DLP-11/2024-25/2420/24-25 dated 26.12.2024 (Document Nos.57 & 58), pursuant to Relinquishment Deed dated 26.03.2025 (Document No.59) by Sobha Limited under which an extent of 1718.01 square metres has been relinquished for the purpose of road widening and 2370 square metres has been relinquished for the purposes of parks and open space from and out of the Project Lands in favour of Bangalore Development Authority. The area remaining in the Project Lands after deduction of the areas relinquished to the Bangalore Development Authority, measuring in all about 19580.67 square metres i.e., approximately 4 Acres 33 <sup>3</sup>/<sub>4</sub> Guntas is hereinafter referred to as "Said Lands".

43. The Endorsement bearing No. LRF: NTC: CR: 416/2008-09 dated 11.09.2008 issued by the Special Tahsildar, Bangalore South Taluk, Bangalore (Document No.74) confirms that no tenancy applications have been filed in Form 7A and under Section 48A of the Karnataka Land Reforms Act, 1961 with regard to Survey Nos. 87/2 and 87/3.

44. The Endorsement bearing No. LRF: CR: 32/2014-15 dated 05.05.2015 issued by the office of the Assistant Commissioner, Bangalore South Sub-Division, Bangalore (Document No.75) confirms that no proceedings have been initiated under Sections 79 A and 79 B of The Karnataka Land Reforms Act, 1961 with regard to portion of Survey No. 87/2 measuring about 7 Acres 30 Guntas and portion of Survey No.87/3 measuring about 5 Acres.

45. The Endorsement bearing No. PTCL: CR: (S): 104/2015-16 dated 05.05.2015 issued by the office of the Assistant Commissioner, Bangalore South Sub-Division, Bangalore (Document No.76) confirms that no proceedings have been initiated under the provisions of The Karnataka Scheduled and Castes Scheduled Tribes (Prohibition on Transfer of Certain Lands) Act, 1978 with regard to portion of Survey No. 87/2 measuring about 7 Acres 30 Guntas and portion of Survey No.87/3 measuring about 5 Acres.

46. The Endorsements confirming that there have been no acquisition proceedings initiated with regard to Survey Nos. 87/2 & 87/3 from the office of the Special Land Acquisition Officer (a) Bangalore Development Authority, (b) Karnataka Housing Board and (c) Karnataka Industrial Areas Development Board were sought by us and M/s Sobha Limited in response thereto have furnished a Letter dated 30.04.2025 (Document No.60) confirming that they have ascertained and satisfied themselves by personal verification in the office of the Special Land Acquisition Officer (a) Bangalore Development Authority, (b) Karnataka Housing Board and (c) Karnataka Industrial Areas Development Board that there are no acquisition proceedings initiated with regard to Survey Nos. 87/2 & 87/3.

47. The Record of Rights, Tenancy & Crops (RTC) Extract / Pahani Patrike furnished to us for the period set out below with regard to Survey No.87/2 discloses the total and the actual extent as 10 Acres, there being no kharab (Document No.79). 63. The Search Report for the period covering 01.12.2015 to 01.03.2025 with regard to Municipal No.2326/SyNo.87/2/SyNo.87/3, Kothanur Village, Ward 194-Gottigere, Bangalore furnished to us does not disclose any other transaction other than those discussed herein above.

**VI. OBSERVATION AND SUGGESIONS:**

Taking into consideration the documents and information furnished, subject to the observations made herein above, subject to tax being paid upto date and Search Reports being brought uptodate, we are of the view that the Project Lands i.e., all that piece and parcel of Property being portion of Municipal No.2326/Sy No.87/2/Sy No.87/3, Kothanur Village, Ward 194-Gottigere measuring in all about 5 Acres 34 Guntas i.e., 23668.68 square metres (i.e., portions of residentially converted land bearing Survey No.87/2 and Survey No.87/3 both situated Kothanur Village, Uttarahalli Hobli, Bangalore South Taluk situated Kothanur Village, Uttarahalli Hobli, Bangalore South Taluk) less the areas measuring about 4088.01 square metres relinquished for the purpose of road widening and parks & open spaces to the Bangalore Development Authority, measuring in all about 19580.67 square metres i.e., approximately 4 Acres 33 ¾ Guntas ("Said Land") vests with Sobha Limited.
