C. TITLE FLOW

Our comments based on the review of the documents provided are as under:

1. We note from the perusal of the documents provided for our review that the land measuring 2 Acres 38 Guntas comprised in Survey No. 30/1 (old Survey No. 30) was originally owned and possessed by Mr. Yellappa *alias* Yelliga and same had been acquired by him by virtue of Sale Deed dated 05.05.1933, registered as Document No. 1028/1933-34, Book-1, Volume-404, at Pages 156 to 159, in the office of the Sub-Registrar, Anekal Taluk.
2. We have been provided with the Preliminary Records bearing No. 30 issued by Tahasildar, Anekal Taluk, in respect of Property. It is noted from the same that the name of Mr. Yellappa

alias Yelliga son of Mr. Shyama has been recorded as the erstwhile person in possession in the Preliminary Records.

3. It is further noted from the documents provided that, Mr. Yellappa *alias* Yelliga died intestate leaving behind his legal heirs *viz.*, (i) Mrs. Muniyamma (wife), (ii) Mr. Gullappa, (iii) Mr. Cheluvaraj and (iv) Mr. Parashuram, wherein (ii) to (iv) are the children of Mr. Yellappa. After the demise of Mr. Yellappa, the said legal heirs *viz.*, Mrs. Muniyamma, Mr. Gullappa, Mr. Cheluvaraj and Mr. Parashuram had entered into a Panchayath Palupatti dated 20.10.1980. As per the Panchayath Palupatti, the property measuring 2 Acres 38 Guntas in Survey No. 30/1 was allotted to the Mr. Cheluvaraj. After acquiring the said property, Mr. Cheluvaraj got the revenue records mutated in his name *vide* entry in the Mutation Register bearing M R No. 3/1994-95.
4. We have been provided with the Genealogical Tree of Mr. Yellappa dated 19.07.1999 issued by Village Accountant, Anekal Taluk. It is noted from the same that Mr. Yellappa was married to Mrs. Muniyamma and they have 3 children out of wedlock *viz.*, Mr. Gullappa, Mr. Cheluvaiah and Mr. Parashuram.
5. We have been provided with the Notarized Genealogical Tree of Mr. Gullappa, son of late Mr. Yallappa. It is noted from the same that Mr. Gullappa is married to Mrs. Kaveramma and they have 5 children out of wedlock *viz.*, (i) Mr. Srinivas, (ii) Mrs. Mangalagowri, (iii) Mr. Muniswami, (iv) Ms. Sumithra and (v) Ms. Renuka. It is noted from the same that Ms. Sumithra, daughter of Mr. Gullappa demised and Mrs. Mangalagowri, daughter of Mr. Gullappa died leaving behind her legal heirs *viz.*, Mr. Manjunath (son) and Mrs. Malashri (daughter). It is further noted that, Mr. Srinivas, son of Mr. Gullappa is married to Mrs. Anjali and they have 3 children out of wedlock *viz.*, Mrs. Deepa, Mrs. Anupama and Mr. Manjunath S.
6. Thereafter, Mr. Cheluvaraj, son of late Mr. Yellappa *alias* Yelliga executed the Sale Deed dated 11.05.2000, registered on 16.10.2000, as Document No. 642/2000-01, Book-1, Volume-2187, at Pages 78 to 87, in the office of the Sub-Registrar, Anekal Taluk in favour of Mrs. Bharathi Eranna, daughter of Mr. Sahukara Gurusiddappa, in respect of the Property. Accordingly, revenue records therein were mutated to stand in the name of Mrs. Bharathi Eranna, daughter of Mr. Sahukara Gurusiddappa *vide* entry in the Mutation Register bearing M R No. 3/2000-01.
7. It is observed that, Mr. M Nagaraj, son of late Muniswamy had filed a suit for Partition bearing O S No. 498/2006 (old O S No.773/2002) against Mr. A Cheluvaraj son of late Yellappa, (1a) Mrs. Rathnamma, wife of late Cheluvaraju, (1b) Mr. C Arun Kumar, son of late Cheluvaraju; (1c) Kumari C Suma, daughter of late Cheluvaraju; (1d) C Nagendra Babu, son of late Cheluvaraju, the defendants No. (1c) and (1d) being minors, represented through their

natural guardian and mother Mrs. Rathnamma, Mr. Y Parashuram, son of late Yellappa and Mrs. I R Bharathi Eranna, wife of Eranna, before the Hon'ble Court of Senior Civil Judge and JMFC at Anekal, Bengaluru Rural District, in respect of Property. The above said suit came to be dismissed *vide* its Order dated 13.02.2015.

8. It is observed that, Mrs. Bharathi I R., wife of Mr. Iranna B R, had executed a Special Power of Attorney dated 19.09.2011, in favour of Mr. Iranna B R, son of Mr. Basappa, appointing him as her attorney to appear and represent her before the Hon'ble Court of Senior Civil Judge and JMFC at Anekal in O S No. 498/2006, to sign, to verify, to file compromise petition and to sign vakalath and to do all the acts that may be necessary in connection with said suit.

ATV Comment: We have not been provided with the copy of the Complaint and the copy of the Order sheet in O S No. 498/2006 (old O S No.773/2002), filed by Mr. M Nagaraj, son of late Mr. Muniswamy against Mr. A Cheluvvaraj, son of late Mr. Yellappa and others.

9. It is observed that, (i) Mr. Sangeeth Raj N., son of late M Nagaraj; (ii) Mrs. Shamala, wife of late M Nagaraj; and (iii) Mr. Somashekar, son of late M Nagaraj (Sl. Nos. ii and iii are not parties) had filed a Regular Appeal No. 5101/2020, against Mr. Cheluvvaraj, since dead, represented by his legal heirs *viz.*, 1(a) Mr. Aruna Kumar; 1(b) Mrs. C Suma; 2. Mr. Y Parashuram, son of late Yellappa; 3. Mrs. I R Bharathi Eranna, before the Hon'ble Court of the III Additional District and Sessions Judge at Bengaluru Rural District for setting aside the Judgement and Decree dated 13.02.2015 in O S No. 498/2006 (old O S No. 773/2002) passed by the Hon'ble Court of Senior Civil Judge and JMFC at Anekal, Bengaluru Rural District. It is observed that, in the said Regular Appeal, an Interim Application was filed for the condonation of delay of 2007 days under Section 55 of the Limitation Act, 1953. The said application was allowed *vide* Order dated 13.07.2022. It is further observed that, the Hon'ble Court of the III Additional District and Sessions Judge at Bengaluru Rural District had dismissed the Regular Appeal and confirmed the Judgement and Decree dated 13.02.2015 in O S No. 498/2006 (old O S No. 773/2002) passed by the Hon'ble Court of Senior Civil Judge and JMFC at Anekal, Bengaluru Rural District *vide* its Order and Judgement dated 26.09.2022.
10. It is further seen that (i) Mr. Sangeeth Raj N, son of late M Nagaraj; (ii) Mrs. Shamala, wife of late M Nagaraj; and (iii) Mr. Somashekar, son of late M Nagaraj had filed a Regular Second Appeal bearing No. 1524/2022 (PAR/DEC) against Mr. Cheluvvaraj, since dead, represented by his legal heirs *viz.*, 1(a) Mr. Arun Kumar; 1(b) Mrs. C Suma; 2. Mr. Y Parashuram, son of late Yellappa; 3. Mrs. I R Bharathi Eranna, before the Hon'ble High Court of Karnataka Bengaluru, against the Judgement and Decree dated 26.09.2022 passed in R A No. 5101/2020 before the III Additional District and Sessions Judge, at Bengaluru Rural District. The appeal was dismissed and the Judgement and Decree dated 13.02.2015, passed in O S No. 498/2006 passed by the Hon'ble Senior Civil Judge at Anekal was confirmed. The above said Regular Second Appeal was dismissed *vide* its Order dated 10.01.2024.

11. It is also seen that, (i) Mr. Sangeeth Raj N, son of late M Nagaraj; (ii) Mrs. Shamala, wife of late M Nagaraj; and (iii) Mr. Somashekar, son of late M Nagaraj had filed a Special Leave Appeal (C) No. 11499/2024 against Mr. Cheluvaraj, since dead, represented by his legal heirs viz., 1(a) Mr. Arun Kumar; 1(b) Mrs. C Suma; 2.Mr. Y Parashuram, son of late Yellappa; 3. Mrs. I R Bharathi Eranna, before the Hon'ble Supreme Court of India. The above said Appeal was dismissed *vide* its Order dated 09.07.2024.
12. Subsequently, on an application filed by Mrs. Bharathi Eranna the Property was converted from agricultural use to non-agricultural residential use *vide* Official Memorandum dated 28.10.2013 bearing reference No. ALN (A.S.H.) S.R/137/2013-14, issued by the Deputy Commissioner, Bengaluru. In this regard, we have also been provided with (i) Demand Notice dated 18.09.2013 bearing reference No. ALN (A.S.H.) S.R/137/2013-14, issued by the office of Deputy Commissioner, Bengaluru calling upon the applicant to pay the requisite conversion fee; and (ii) Challan to evidence the payment of conversion fee, in respect of the aforesaid conversion. Accordingly, factum of the conversion was recorded in the revenue records *vide* entry in the Mutation Register bearing MR No. T31/2020-21.
13. Thereafter, Mr. Parasurama Y, son of late Mr. Yellappa had filed a suit for partition and separate possession bearing O S. No. 964/2012 against (1). Mrs Kaveramma, wife of late Gullappa, (2). Mr. Arun Kumar C., son of late Mr. Cheluvaraj, (3). Mrs. Suma, daughter of late Mr. Cheluva Raj, (4). Mrs. Muniyamma, daughter of late Mr. Yellappa dead by legal heirs viz., (4a) Mr. Prasanna Kumar, son of late Mrs. Muniyamma, (4b) Mrs. Shobha, daughter of late Mrs. Muniyamma, (5). Mrs. Bharathi Eranna, (6). Mr. Srinivas, son of late Mr. Gullappa, (7). Mrs. Deepa S., daughter of Mr. Srinivas, (8). Mrs. Anupama S., daughter of Mr. Srinivas, (9). Mr. Manjunatha S., son of Mr. Srinivas, (10). Mr. Manjunatha, son of late Mrs. Mangalagowri, (11). Mrs. Malashri, daughter of late Mrs. Mangalagowri, (12). Mrs Rathnamma, wife of late Mr. Muniswamy, (13). Mr. Parashuram, son of late Mr. Muniswamy, (14). Mrs. Kalavati, daughter of late Mr. Muniswamy, (15). Mr. Shivaram Prasad, son of late Mr. Sumithra, (16). Mr. Om Prakash, son of late Mrs. Sumithra, (17). Mrs. Renuka, daughter of late Mr. Gullappa, (18). Mrs. Usha Rani, wife of late Mr. Munikrishna, (19). Mrs. Shantha Lakshmi, daughter of late Mr. Munikrishna, (20). Mrs. Sathya, daughter of late Mr. Munikrishna, (21). Mr. Govindaraju, son of Mrs. Shamakka, (22). Mrs. Ramakka, daughter of late Mr. Yellappa, (23). Mrs. Muniyamma, daughter of late Mr. Yellappa before the Hon'ble Court of the Senior Civil Judge and JMFC at Anekal. In the said case, the parties have arrived at a settlement and accordingly, they have filed a Compromise Petition under Order 23 Rule 3 of the Code of Civil Procedure, 1908. As per the Compromise Petition, the property measuring 1 Acre and 38 Guntas (out of 2 Acres and 38 Guntas) in Survey No. 30/1 was allotted to Mrs. Bharathi Eranna, (i.e., Defendant No. 5), and the property measuring 1 Acre in Survey No. 30/1 was allotted to the Mr. Y. Parasurama (i.e., Plaintiff). As per Compromise Petition, the Hon'ble Court was pleased to draw a Final Decree and the same has been

registered on 16.11.2016, as Document No. 3069/2016-17, Book-1, stored in C. D. No. SRJD217, in the office of the Sub-Registrar, Basavanagudi, (Sarjapura), Bengaluru. As per the Compromise Petition, the property measuring 1 Acre and 38 Guntas (out of 2 Acres and 38 Guntas) in Survey No. 30/1 allotted to Mrs. Bharathi Eranna, (i.e., Defendant No. 5), in terms of a Final Decree for Partition bearing O. S. No. 964/2012, was registered on 16.11.2016, as Document No. 3106/2017-18, Book-I, stored in C D No. SRJD217, in the office of the Sub-Registrar, Basavanagudi (Sarjapura), Bengaluru.

14. Subsequently, the daughters of late Mr. Yellappa viz., Mrs. Shamakka, Mrs. Ramakka, Mrs. Muniyamma and Mrs. Muniyamma had filed suit for Partition and separate possession bearing O S No. 62/2013 against (1). Mrs. Kaveramma, wife of late Gullappa, (2). Mrs. Mangala, daughter of late Mr. Yellappa, (3). Mr. Srinivas, son of late Mr. Gullappa, (4). Mrs. Renuka, daughter of late Mr. Gullappa, (5). Mr. Arun Kumar C., son of late Mr. Cheluvvaraj, (6). Mrs Suma, daughter of late Mr. Cheluvva Raju, (7). Mr. Parashurama, son of late Mr. Yellappa and (8). Mrs. Bharathi Eranna before the Hon'ble Court of Senior Civil Judge and JMFC at Anekal. In the said suit, the parties had arrived for settlement and hence, the Plaintiffs i.e., Mrs. Shamakka, Mrs. Ramakka, Mrs. Muniyamma and Mrs. Muniyamma had filed a Memo for seeking permission to dismiss the suit as not pressed as they have settled the matter in O S No. 964/2012. Hence, in view of the memo, the suit of the Plaintiffs was dismissed as not pressed *vide* its Order dated 15.07.2016.
15. It is observed that Mrs. Deepa S, Mrs. Anupama S., and Mr. Manjunath S., had filed a Writ Petition bearing WP No. 10654/2019 against Mr. Parasurama and his family members before the Hon'ble High Court of Karnataka at Bengaluru for setting aside the Order dated 28.07.2017, passed by the Senior Civil Judge, Anekal Taluk on Interim Application No.1 in O S No. 964/2012 and recall the Order of Compromise dated 15.07.2016.
16. It is observed that, Mr. Chinnappa, son of late Mr. Chikka Konkappa had filed a suit for specific performance bearing V. O. S. No. 190/2014 before the Hon'ble Court of the Vacant District and Sessions Judge at Bengaluru in O. S No. 308/2014 before the Court of the Junior Civil Judge at Anekal Taluk against (1). Mrs. Kaveramma, wife of late Mr. Gullappa, (2). Mr. G. Srinivas, son of late Mr. Gullappa, (3). Mrs. Mangalagowri, daughter of late Mr. Gullappa, (4). Mr. Muniswamy, son of late Mr. Gullappa, (5). Mr. Shivaprasad, son of late Mrs. Sumithra, (6). Mr. Omprakash, son of late Mrs. Sumithra, (7). Mrs. Renuka, daughter of late Mr. Gullappa, (8). Mr. Arun Kumar, son of late Mr. Cheluvvaraj, (9). Mrs. Suma, daughter of the late Mr. Chalavaraj, (10). Mrs. Bharathi Eranna, daughter of Mr. Sahukar Gurusiddappa. In the above said suit, the parties have arrived at a settlement and hence, Plaintiff i.e., Mr. Chinnappa had filed a memo to dismiss the suit and accordingly, the Hon'ble Court has dismissed the suit.

17. It is further observed that, Mrs. Kaveramma, Mr. Srinivas G., Mrs. Deepa, Mr. Manjunath S., Mrs. Mangalagowri, Mrs. Muniswamy, Mr. Ramu G., Mrs. Kalavathi, Mr. Shivaram Prasad, Mr. Om Prakash, Mrs. Renuka, Mrs. Anupama had filed an appeal under Section 136(2) of the Karnataka Land Revenue Act, 1961 bearing No. RA (A) 245/2014-15 against the Tahasildar, Mr. Arun, Mrs. Suma and Mrs. Bharathi Eranna, before the Court of the Assistant Commissioner, Bengaluru South Sub-Division at Bengaluru for setting aside the entries in the Mutation Register bearing M R. No. 3/1994-95 and M R. No. 3/2000-01. The said appeal came to be allowed *vide* Order dated 01.04.2015. As per the said Order, the khatha in respect of the Property was mutated to stand in the name of Mrs. Kaveramma *vide* entry in the Mutation Register bearing MR No. H81/2014-15.
18. Thereafter, Mrs. Bharathi Eranna, daughter of Mr. Sahukar Gurusiddappa had filed a Revision Petition bearing No. 22/2015-16, under Section 136(3) of Karnataka Land Reforms Act, 1964 before the Court of the Deputy Commissioner, Bengaluru, against the Assistant Commissioner, Bengaluru South Sub-Division, the Tahsildar, Anekal Taluk, for setting aside the impugned Order dated 01.04.2015, bearing No. RA(A):245/2014-15 passed by the Assistant Commissioner, Bengaluru South Sub-Division, Bengaluru. In light of the settlement arrived in the OS. No.964/2012, the Parties filed a Joint Memo to withdraw the above said Revision Petition. As per the Joint memo, the Hon'ble Court of the Deputy Commissioner dismissed the Revision Petition *vide* its Order dated 07.10.2016.
19. Subsequently, Mrs. Bharathi Eranna had filed a suit for permanent injunction bearing O. S. No. 242/2015 against Mrs. Kaveramma and her family members before the Court of Civil Judge (Junior Division) and JMFC at Anekal. In the said suit, the Plaintiff had filed a memo to dismiss the suit as not pressed. As per the Memo the Hon'ble Court was pleased to dismiss the said suit. In the meanwhile, Mrs. Kaveramma, wife of late Mr. Gullappa had executed a Gift Deed in favour of her daughter-in-law, Mrs. Anjali, wife of Mr. Srinivas *vide* Gift Deed dated 28.10.2016, registered as Document No. 4953/2016-17, Book-1, stored in C.D. No. ANKD412, in the office of the Sub-Registrar, Anekal Taluk. Accordingly, revenue records therein were mutated to stand in the name of Mrs. Anjali, wife of Mr. Srinivas *vide* entry in the Mutation Register bearing M R No. 35/2016-17.
20. Thereafter, Mrs. Bharathi Eranna had filed a suit for declaration and possession bearing O S No. 22/2018 against Mrs. Anjali before the Hon'ble Court of the Senior Civil Judge and JMFC at Anekal. In the said suit, the parties arrived at a settlement and hence filed a Compromise Petition before the Hon'ble Court. Accordingly, the Hon'ble Court was pleased to pass a Compromise Decree *vide* an Order dated 07.02.2024.
21. It is observed that, Mr. Parasurama Y., had filed a suit for declaration and injunction bearing O. S No. 23/2018 against Mrs. Anjali before the Hon'ble Court of the Senior Civil Judge and JMFC at Anekal. In the said suit, the parties arrived at settlement and hence filed a

Compromise Petition before the Hon'ble Court, Accordingly, the Hon'ble Court was pleased to pass a Compromise Decree *vide* an Order dated 07.02.2024

22. Thereafter, Mrs. Kaveramma, wife of late Mr. Gullappa and Mrs. Anjali, wife of late Mr. Srinivas and Mr. B.R. Venkatachalapathy, son of Mr. Ramakrishna had entered into an Agreement for Sale dated 23.02.2017, registered as Document No. 4334/2016-17, Book-1, stored in C.D. No. SRJD227, in the office of the Sub-Registrar, Basavanagudi (Sarjapura), Bengaluru. Thereafter, the said Agreement for Sale was cancelled *vide* Cancellation of Sale Agreement dated 30.06.2017, registered as Document No.1950/2017-18, Book-1, stored in C. D. No. ANKD423, in the office of the Sub-Registrar, Anekal Taluk, Bengaluru.

ATV Comment: We have not been provided with (i) the Cancellation of Sale Agreement dated 30.06.2017, registered as Document No.1950/2017-18, Book-1, stored in C. D. No. ANKD423, in the office of the Sub-Registrar, Anekal Taluk, Bengaluru; and (ii) the Death Certificate of Mrs. Kaveramma.

23. Thereafter, Mrs. Anjali, wife of late Mr. Srinivas had filed an appeal bearing No. R.A (A)153/2018-19 against Mrs. Kaveramma before the Court of the Assistant Commissioner, Bengaluru District, regarding the transfer of khatha in the name of Mrs. Anjali. The said application was allowed *vide* an order dated 18.09.2018. Subsequently, Mrs. Bharathi Eranna filed a Revision Petition under Section 136(3) of Karnataka Land Revenue Act, 1964 bearing Revision Petition No. 248/2018-19 before the Deputy Commissioner, Bengaluru District, Bengaluru to set aside the Order dated 28.09.2018, passed by the Assistant Commissioner, Bengaluru District. The said Revision Petition came to be dismissed *vide* its Order dated 15.09.2020. It is observed that, Mrs. Bharathi Eranna had filed a Writ of Certiorari bearing WP No.11756/2020(KLR-RR/SUR) against (i) the State of Karnataka; (ii) the Deputy Commissioner; (iii) the Assistant Commissioner; (iv) the Tahasildar; and (v) Mrs. Anjali, wife of late Mr. Srinivas, for quashing the Order dated 18.09.2018, passed in R.A (A)153/2018-19 and the Order dated 15.09.2020, passed in Revision Petition No. 248/2018-19, before the Hon'ble High Court of Karnataka at Bengaluru. The above said Writ Petition was allowed and accordingly, the Hon'ble High Court quashed the Order dated 18.09.2018, passed in R.A (A)153/2018-19 and the Order dated 15.09.2020, passed in Revision Petition No. 248/2018-19.
24. Subsequently, Mrs. Anjali, the wife of the late Srinivas, filed a Review Petition under Order XLVII Rule 1 of the CPC, bearing R.P. No. 41/2020, against (i) Mrs. Bharathi Eranna, (ii) the State of Karnataka, (iii) the Deputy Commissioner, (iv) the Assistant Commissioner, and (v) the Tahasildar, before the Hon'ble High Court of Karnataka at Bengaluru. The petition sought to review the Judgment and Order dated 04.12.2020 in W.P. No. 11756/2020. In the said Review Petition, the order dated 04.12.2020 in W.P. No. 11756/2020 passed by the Hon'ble High Court at Bengaluru was recalled, and the matter was restored for reconsideration, as per the Order dated 08.02.2021. Thereafter, following the order in the Review Petition, Writ Petition No. 11756/2020 was recalled. However, the petitioner, Mrs. Bharathi Eranna, filed a

memo before the Hon'ble High Court seeking withdrawal of the Writ Petition. The Hon'ble High Court considered the memo and dismissed the Writ Petition as withdrawn, as per the Order dated 15.06.2023.

25. It is observed that, Mrs. Anjali and Mrs. Anupama and Mr. M. Krishnappa had entered into an Agreement for Sale dated 03.07.2017, registered as Document No.2023/2017-18, Book-1, stored in C.D. No. ANKD423, in the office of the Sub-Registrar, Anekal Taluk, Bengaluru. Subsequently, the said Agreement for Sale was cancelled *vide* Cancellation of Sale Agreement dated 02.05.2023, registered as Document No.1051/2023-24, Book-1, stored in C.D. No. ANKD 155, in the office of the Sub-Registrar, Anekal Taluk, Bengaluru.

ATV Comment: We have not been provided with the Cancellation of Sale Agreement dated 02.05.2023, registered as Document No.1051/2023-24, Book-1, stored in C.D. No. ANKD 155, in the office of the Sub-Registrar, Anekal Taluk, Bengaluru.

26. It is observed that, Mrs. Bharathi Eranna had filed a suit for injunction bearing O S No. 504/2016 against Mrs. Kaveramma, Mr. Srinivas G., Mrs. Anjali, Mrs. Deepa S., Mrs. Anupama S., Mr. Manjunath S., before the Hon'ble Court of the Civil Judge and JMFC at Anekal. In above said suit, the Hon'ble Court was pleased to pass an Order for Temporary Injunction *vide* its Order dated 17.01.2020 against the defendants *viz.*, Mrs. Kaveramma, Mr. Srinivas G., Mrs. Anjali, Mrs. Deepa S., Mrs. Anupama S., Mr. Manjunath S., restrained from alienating the property and restrained interfering to the possession of the property till disposal of the suit. It is observed that, the parties have arrived for settlement and hence, they have filed a compromise petition under Order 23 Rule 3 of Civil procedure code, 1908 before the Hon'ble Court. As per compromise petition, the Hon'ble Court was pleased draw a Compromise Decree, *vide* Order dated 11.03.2025.

ATV Comment: We have not been provided with the copy of the Compromise Petition in O S No. 504/2016 and a copy of the Order Sheet.

27. It is further seen that Mrs. Anjali, wife of late Mr. Srinivas, had filed a memorandum of Miscellaneous Appeal No. 5/2020, aggrieved by the Temporary Injunction Order dated 17.01.2020, in O.S. No. 504/2016 passed by the Hon'ble Court of the Civil Judge and JMFC at Anekal. It is further observed that Mrs. Anjali, wife of late Mr. Srinivas, had filed a memo dated 11.03.2025 in the above Miscellaneous Appeal, stating that the parties settled outside of the court. Accordingly, the Miscellaneous Appeal was dismissed *vide* an Order dated 11.03.2025.
28. It is further observed that, Mrs. Anjali, wife of late Srinivas had filed appeal under Section 136(2) of the Karnataka Land Revenue Act 1964 bearing No. RA/(A)/375/2022 against M R No. H30/2020-21 in respect of the land measuring 1 Acre out of 2 Acres and 38 Guntas in

Survey No. 30/1 before the jurisdictional Assistant Commissioner, Bengaluru South Sub-Division, Bengaluru. In the said Appeal, Mrs. Anjali filed a memo stating that the dispute had been settled outside the Court and sought permission for the withdrawal of the appeal. Based on the memo, the Hon'ble Court dismissed the appeal *vide* its Order dated 29.03.2023

29. It is also noted that Mrs. Anjali, the wife of the late Srinivas, filed an Appeal under Section 136(2) of the Karnataka Land Revenue Act, 1964, bearing No. RA/(A)/373/2022, against M.R. No. H29/2020-21 in respect of the land measuring 1 Acre 38 Guntas, out of 2 Acres 38 Guntas in Survey No. 30/1, before the jurisdictional Assistant Commissioner, Bengaluru South Sub-Division, Bengaluru. In the said Appeal, Mrs. Anjali filed a memo stating that the dispute had been settled outside the Court and sought permission for the withdrawal of the appeal. Based on the memo, the Hon'ble Court dismissed the appeal *vide* its Order dated 29.03.2023.
30. It is observed that, Mrs. Ramakka, daughter of late Mr. Yellappa, Mrs. Muniyamma daughter of late Mr. Yellappa, Mr. Prasanna Kumar, son of late Mrs. Muniyamma, , Mrs. Shobha, daughter of late Mrs. Muniyamma, Mr. Govindaraju, son of late Shamakka, Mr. Arun Kumar, son of late Mr. Cheluvaraju and Mrs. Suma, wife of late Mr. Cheluvaraju had jointly executed a Release Deed in favour of Mr. Y Parashuram, son of late Mr. Yellappa, releasing all their rights/title/interest over the Property *vide* Release Deed dated 10.05.2022, registered as Document No. 1805/2022-23, Book-1, stored in C D No. BSKD1306, in the office of the Sub-Registrar, Basavanagudi (Banashankari), Bengaluru.
31. Thereafter, Mrs. Bharathi Eranna and Mr. Parasurama, son of late Mr. Yellappa ("Owners") and T G Developers Prime Realty Private Limited, a company, incorporated under the provisions of the Companies Act, 2013, represented by its authorized signatory and Managing Director Mr. Sandeep Kumar S., son of Mr. B M Suresh ("Developer") have formulated a scheme for developing the Property into a residential complex and accordingly entered into a Memorandum of Agreement ('**MOU**') dated 27.02.2023, registered as Document No. 15278/2022-23, Book-I, stored in C.D. No. BSKD1525, in the office of the Sub-Registrar, Basavanagudi (Banashankari), Bengaluru. Wherein, Mr. Manjunath S., son of late Mr. Srinivas, Mrs. Anjali, wife of late Mr. Srinivas, Mrs. Anupama, daughter of late Mr. Srinivas and Mrs. Deepa, daughter of late Mr. Srinivas joined as confirming parties in the above said MOU.
32. It is observed that, Mrs. Bharathi Eranna and Mr. Parasurama, son of late Yellappa and T G Developers Prime Realty Private Limited, a company, incorporated under the provisions of the Companies Act 2013, represented by its Authorized Signatory and Managing Director Mr. Sandeep Kumar S., son of Mr. B M Suresh, have entered into a Joint Development Agreement dated 05.04.2024, registered as Document No. 00391/2024-25, Book-1, in the office of the Sub-Registrar, Banashankari, Bengaluru, in respect of the Property.

33. We have been provided with the Approved Building License Plan dated 10.03.2025, bearing LP No. 63/2023-24, issued by the Bangalore Development Authority in the name of Mrs. Bharathi Eranna and Mr. Yellappa Parashurama, represented by their Joint Attorney Holder TG Prime Realty Private Limited in respect to the Property. As per the said plan, the approval is issued for the construction of the (i) Tower-1, consisting of Wing -A with stilt + ground and Wing-B with stilt + ground floor + 14 upper floors, (ii) Tower -2, consisting of Wing- C with stilt + ground floor + 14 upper floors and Wing- D with stilt + ground floor + 14 upper floors, and (iii) Amenity Block consisting of stilt + ground floor + 2 upper floors.
34. We have been provided with the Property Tax paid receipt for the period of 2024-25 to evidence the payment of the Property tax in respect of the Property.
35. We have been provided with Form 9 and 11 (E-Katha) Certificate issued by Shanthipura Gram Panchayat in respect of Property.
36. We have been provided with the RTCs issued for the period from (i) 1969-70 to 1987-88, (ii) 1989-90 to 1992-93, (iii) 1993-94 to 1999-2000, and (iv) 2000-01 to 2016-17. We have been provided with the following RTC extracts issued in respect of the Property.

from the same that the land in Survey No. 30 has been sub-divided into 4 parcels *viz.*, 30/1, 30/2, 30/3 and 30/4.

39. We have been provided with the Comprehensive Development Plan in respect of the Property. The same confirms that the conversion of the Property is as per the zoning.
40. We have been provided with the Village map of Gattahalli. It reflects the location, shape, and boundaries of Survey No. 30.
41. We have been provided with the Encumbrance Certificates issued for the periods (i) 01.04.1933 to 31.03.1994; (ii) 01.04.2004 to 22.11.2016; (iii) 01.07.2017 to 03.07.2017 and (iv) 01.04.2004 to 10.03.2025 in respect of Property. In terms of the same, the following transactions are reflected:
